Mary's Place is very appreciative of how the White Center community has welcomed us in and embraced our work to support homeless families in crisis here. We have placed dozens of families into permanent housing, helping them get back on track and stabilized in housing. We couldn't have done it without the support and generosity of the White Center community.

With this in mind, we fully support the community effort to re-develop the former White Center public health site into a wonderful community asset providing important, life-saving services for White Center.

When we moved into this location, we knew that it would be temporary. Our operating model is to move into unused buildings and turn them into temporary shelter. We are continually working to develop new locations to ensure that we are ready to move when the time comes. When we move from the public health building, we will ensure that all of our families are successfully placed in housing, or one of other nearby locations.

We understand the complexities and unknowns of funding and developing social services facilities and housing. Be assured, we are eager to work closely with you both in your efforts and do not want our temporary use of this building to have a negative impact on the realities of re-development investment opportunities and the benefits for the community.

As the planning and design for the new White Center Community HUB (former public health site) gets underway in earnest, I wanted to take a moment to clarify the position of the White Center Food Bank.

February 16, 2018

Originally, the Food Bank was going to be one of the service agencies co-located in the new development. While we continue to fully support the project, we have determined that, due to an ongoing internal review of our food bank service model options, and due to the considerable physical improvements needed at the current building, ultimately it will be better for the Food Bank to be relocated to a site closer to transit.

We are grateful to continue to be a social service partner in White Center, in the HUB project and very much appreciate the invitation to have Carmen Smith, our Development Director, participate in the Neighborhood Advisory Council to provide input. We believe the vision of having affordable housing and critical social support services located at the site will be hugely beneficial to the White Center Community.

Whether or not we are physically a part of the HUB, we want to continue in our collaboration with you and your organizations to provide White Center families with food and services to allow them to thrive. We intend to cooperate to the fullest extent to help make the redevelopment a reality and have it become a true asset to the community.


